Course fees include the course syllabus. Exam fees cover only the exam and do not include the course syllabus. However, it may be purchased separately by those who wish to do so. ## 10. Course Definition

*Clinician Course:* Open to MDs, PhDs, DOs, Nurse Practitioners, Physician Assistants, Fellows and Residents.

*Technologist Course:* Open to any allied health professional performing DXA scans.

*Clinician Course for Technologists:* Technologists may attend the Clinician Course if gaining information about interpreting DXA scans would assist them with their job responsibilities. However, it is recommended that the Technologist Course be taken first.

## 11. Prerequisites

*Clinician Course:* Must be in good standing with your licensing organization.

*Technologist Course:* **Must have experience performing DXA Scans.** This is an intermediate level course and is therefore not a suitable course for beginners who have no experience doing DXA scans.

*Fellow/Resident:* Must be in good standing with Fellow program (attestation required).

## 12. Course Objectives

*Clinician Course:* After attending the course, participants should be better prepared to:

- Identify the technique, safety and limitations of DXA scans
- Explain the value of utilizing bone densitometry to assess and monitor fracture risk.
- Summarize quality assurance and calculation of precision at a DXA site.

- Apply the principles of DXA scan interpretation in reporting.

*Technologist Course:* After attending the course, participants should be better prepared to:

- Identify the technique, safety and limitations of DXA scanning
- Explain the value of utilizing bone densitometry to assess and monitor fracture risk
- Apply knowledge of quality control and operation of DXA equipment.
- Review patient preparation and proper positioning for DXA scanning.
- Identify and perform proper scan acquisition and analysis

## 13. Accreditation Statement

The International Society for Clinical Densitometry is accredited by the Accreditation Council for Continuing Medical Education (ACCME) to offer continuing medical education for physicians.

## 14. Credit Designation

The International Society for Clinical Densitometry designates this educational activity for a maximum of *12.0 AMA PRA Category 1 Credit(s)*<sup>™</sup>. Physicians should only claim credits commensurate with the extent of their participation in the activity.

*Technologist Course:* The course qualifies for 13.5 category A credits through the ASRT. Technologists must sign in and out each day to verify attendance and receive credit. Partial credit will not be given.

*Clinician Course for Technologists:* The course qualifies for 14 category A credits through the ASRT. Technologists must sign in and out each day to verify attendance and receive credit. Partial credit will not be given.

## 17. Certification Exam

To become certified, it is necessary to pass the Certification Exam. The US Technologist Certification Exam is offered several times per year at locations throughout the United States, unless otherwise specified. Technologists who wish to take the exam may print the exam application form and handbook from the ISCD Web site. The Clinician Certification Exam is offered immediately following the course at each course location and is paper and pencil. Attendance at the course is not required for either exam. Outside the US, both the technologist

and Clinician Certification Exams will be offered immediately following the course at each course location (attendance at the course is not required). The ISCD Clinician and Technologist certification exams are based upon the certification content outline developed from a Practice/Job Analysis survey. Exam questions are mapped to the core references for each examination.
